#### **OPEN LETTER TO MBBS ABROAD ASPIRANTS**

Dear MBBS In Abroad Aspirants,

MBBS Abroad comes as an excitement for the MBBS aspirants but in current situation studying medicine overseas needs to be checked with utmost caution due to the fresh conditions imposed by National Medical Commission.

National medical commission had issued a warning on 8th August 2023 that many MBBS Abroad Universities are not fulfilling the NMC FMGL conditions completely and in case of any variation student will be disqualified to get registration in India and the complete respon-sibility will rest with the student only.



Following are the conditions of (FMGL) Foreign Medical Graduate Licentiates Regulations 2021 (dated 18 November 2021) required to be fulfilled by any college/country.
